WNML'S MICHELOB ULTRA BETTER THAN A BIRDIE GOLF CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WNML FM/AM ("Station"), owned and operated by Cumulus Radio LLC, 4711 Old Kingston Pike, Knoxville, TN 37919, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WNML** "Michelob Ultra Better Than a Birdie Golf" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - Remote Broadcast & Text: Attend a Budweiser sponsored remote broadcast (each a "Remote (i) Broadcast") conducted by Station to get the secret text entry keyword. Send a text message with the keyword spelled correctly specified at that Remote Broadcast to 68255. We will select 3 entries from each of the 15 remote broadcasts to qualify as "finalists." The Remote Broadcast locations, dates, and times will be posted and updated daily at the following URL: www.991thesportsanimal.com.com. Station reserves the right to remove or otherwise modify the dates, times, or locations of the Remote Broadcasts throughout the Contest Period at the Station's sole discretion. Limit one (1) entry per person per phone number per Remote Broadcast. All entries must be received by by the deadline stated at each Remote Broadcast to be eligible to win. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

(ii) Online Entry: Visit www.991thesportsanimal.com and fill out an entry. One entry per person allowed.

Winner Selection. On or about 5:00pm ET on April 30, 2021, Station will select one (1) entry for the Grand Prize (as defined below) in a reverse random drawing from among all qualified valid entries selected as "finalists" during the remotes as well as one entry selected from all of the online entries received by Station during the Contest Period. All the valid entries received by Station during the Contest Period will be placed in a container and removed one (1) at a time. The last finalist entry drawn from the container will be the Grand Prize winner. The winner need not be present at Edwin Watts Golf, 11364 Parkside Drive, Knoxville, TN 37934 to win. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
