## WNML'S "BIG TICKET 2022" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WNML-FM ("Station"), 4711 Old Kingston Pike, Knoxville, TN 37919, during available business hours Monday through Friday, on the Station website <a href="https://www.991TheSportsAnimal.com">www.991TheSportsAnimal.com</a>, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WNML's "Big Ticket 2022" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 365 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 365 days. Void where prohibited by law. Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Contest Period. The Contest entry period will begin at 12:01am ET on May 31, 2022, and will run until 4:00pm ET through July 14, 2022. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

Remote Broadcast: Attend a designated "Big Ticket 2022" remote broadcast conducted by Station (each a "Remote Broadcast") and complete an entry form. The locations, dates, and times of the Remote Broadcasts will be posted and updated at the following URL: <a href="www.991TheSportsAnimal.com">www.991TheSportsAnimal.com</a>, as new remote broadcast locations are added or otherwise modified throughout the Contest Period at the Station's sole discretion. Station will have a maximum of seventy-five (75) Remote Broadcasts during the Contest Period. The final Remote Broadcast will be Thursday, July 14, 2022, and the deadline for entry is approximately 4:00pm ET. Limit one (1) entry per person per Remote Broadcast. All entries must be received by the deadline stated at the Remote Broadcast. At the conclusion of each Remote Broadcast, Station will randomly draw two (2) entries from among all entries received by Station at that Remote Broadcast to be qualified for the Grand Prize Event for the chance to win (as defined below) (subject to verification of eligibility and compliance with the terms of these rules) (each a "Finalist"). The total number of Finalists for the Contest will not exceed one hundred fifty (150.)

4. **Winner Selection.** The Grand Prize Event will be held on Thursday, July 14, 2022, at Pinnacle at Turkey Creek, 11251 Parkside Drive, Knoxville, TN 37934. Finalists are required to check-in with Station between 5:00 p.m. – 6:00 p.m. ET. Any Finalist who has not checked in with Station by 6:00 p.m. ET will be disqualified. Finalists are permitted to have a stand-in serve as a substitute; provided, that (i) the stand-in is eighteen (18) years of age or older, (ii) presents a valid government issued photo ID, and (iii)

presents a copy of the Finalist's government issued photo ID. Each Finalist will receive three (3) entry tickets after they register at check in with Station. Each Prize (i.e., set of season tickets described below) will be represented with a depository for tickets to indicate the Finalist's interest to win that sport's season tickets. A Finalist may choose to place as many of their tickets into any one depository as they choose. For example, a Finalist could place all three (3) of their tickets in one (1) season ticket bucket or one (1) ticket in three (3) separate season ticket buckets. Any ticket not placed in a depository by 6:15pm ET is disqualified and cannot be used. At 6:15pm ET the drawings will begin to give away each set of season tickets. MUST BE PRESENT TO WIN. Station will select one (1) entry in a random drawing for each set of season tickets from among all tickets placed in the depository for the specific set of season tickets. A Finalist may only win one (1) Prize. Should a Finalist be drawn for more than one (1) Prize, they must choose one (1) Prize to claim and relinquish the other. Station will select another winner for any Prize that is forfeited from the remaining entries for that Prize. The Contest will conclude once all season tickets which received tickets in their respective depository are given away. All winning Finalists will be awarded their respective Prize subject to verification of eligibility and compliance with the terms of these rules. Station's decisions as to the administration and operation of the Contest and the selection of the winners and the entries drawn at the Remote Broadcast locations are final and binding in all matters related to the Contest. Failure to respond to claim the prize within thirty (30) days of winning will result in disqualification.

Sponsor makes no representation or warranty about the safety of any Remote Broadcast or the Grand Prize Event in light of COVID-19. Any public location where people are present provides an inherent risk of exposure to COVID-19, and Sponsors cannot guarantee that any person will not be exposed during a visit to a public place. By attending a Remote Broadcast or the Grand Prize Event, participants acknowledge the risk of large group gatherings and assume all risks of attending a Remote Broadcast or the Grand Prize Event.

- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Unclaimed prizes may not be awarded.

  - · Season tickets to the Knoxville Ice Bears 2022-2023. ARV Five Hundred Dollars (\$500)

The total aggregate ARV of all prizes awarded in this contest is up to Six Thousand Three Hundred Fifty Dollars. (\$6350.00)

For entry to the prize event(s), each event attendee may be required to show valid proof of vaccination against the COVID-19 virus and/or valid proof of a negative test for the COVID-19 virus within 72 hours (or such other time as the event organizers require) prior to the event(s).

Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning a prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

Any tickets and/or gift certificates/cards awarded as part of a prize will be subject to the terms and conditions set forth by the issuer and are valid only on the date(s) printed on the tickets or gift certificates/cards. Other restrictions may apply.

If any prize or a portion of any prize is postponed, cancelled, or otherwise unavailable due to disease, epidemic, pandemic, quarantine, any acts of government and/or any reason that is beyond the control of Station or any Sponsor, then no substitution shall be provided. Station and any Sponsors make no representation or warranty about the safety of any prize. By accepting and using a prize, each winner acknowledges and assumes all risks of accepting and using the prize, and any other risks associated with the prize.

- 7. Entry Conditions and Release. - 10. **General Conditions.** Station reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Station in its sole discretion. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 11. **Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, Sponsor, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
- 12. **Disputes.** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
- 13. **Entrant's Personal Information.** Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained therein, shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no

- responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
