WNML'S "COORS LIGHT GRILL IT & CHILL IT" CONTEST OFFICIAL RULES

The Station will conduct the WNML "Coors Light Grill It & Chill It" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. When the Station plays the "cue-to-call" sounder, one play each weekday in each of the following periods, 6am-9am, 9am-12noon, 12noon to 3pm and 3pm to 7pm, listeners must call the Station at 865-656-WINS or 865 656-9467. Caller five (5) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. *Time Delay*

- 4. **Winner Selection.** On or about 6:00pm ET on Wednesday, March 15, 2023, Station will select one entry in a random drawing to win the Grand Prize from all the valid Qualifiers in the contest. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
