WNML'S MICHELOB ULTRA BETTER THAN A BIRDIE CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WNML FM/AM ("Station"), during normal business hours Monday through Friday, on the Station website, www.991thesportsanimal.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WNML** "Michelob Ultra Better Than a Birdie" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - Remote Broadcast: Attend a Michelob Ultra sponsored remote broadcast (each a "Remote (i) Broadcast") conducted by Station and complete an entry form. Limit one (1) entry per person per Remote Broadcast. All entries must be received by the deadline stated at the Remote roadcast. At the conclusion of each Remote Broadcast, Station will select (4) entries to qualify to win the Grand Prize (as defined below) (each a "Qualifier") from among all valid entries received by Station during that Remote Broadcast. Station will update the details for the Remote Broadcast on its website and announce on-air at least one (1) day prior to the Remote Broadcast. On or about 6:10pm ET, Station will conduct a reverse random drawing from among all Qualifiers that are present and checked in at the Event. All Qualifiers' names will be placed in a container and removed randomly one (1) name at a time. The last Qualifier remaining in the container will be the Grand Prize winner. The winner must be present to win. The winning entrant will be notified at the time of the drawing and may be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).
