#### WNML'S HOOP TEA MADNESS CONTEST OFFICIAL RULES

The Station will conduct the WNML "Hoop Tea Madness" Contest substantially as described in these rules, and by participating, each entrant agrees as follows:

Eligibility. Any Qualifier not checked in by 6:00pm ET will be disqualified from the Contest. On or about 6:10pm ET, Station will conduct a reverse random drawing from among all Qualifiers that are present and checked in at the Event. All Qualifiers' names will be placed in a container and removed randomly one (1) name at a time. The last Qualifier remaining in the container will be the Grand Prize winner.
