

**WNML-FM's "SCORE-A-FORD" CONTEST
OFFICIAL RULES**

A complete copy of these rules can be obtained by contacting radio station WNML-FM 99.1 the Sports Animal, 4711 Old Kingston Pike, Knoxville, TN 37919, during available business hours Monday through Friday, on the Station website www.991thesportsanimal.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WNML-FM's "Score-A-Ford" Contest substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 365 days and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 365 days. **Void where prohibited by law.** Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest entry period will **begin at 6:00am ET on Monday, August 25th, 2025 and will run weekdays from 6:00am ET until 7:00pm ET through 7:00pm ET on Saturday, November 29th, 2025, except the Contest will not run from September 29th through October 4th and November 3rd through November 8th due to no University of Tennessee games being scheduled.** The Station's computer is the official timekeeping device for this Contest.

3. **How to Enter.**

On-Air: Listen to Station weekdays from 6:00am-9:00am, 9:00am-12:00pm (noon), 12:00pm (noon)-3:00pm, and 3:00pm-6:00pm ET during each Contest Round. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 865-656-9467. Caller five (5) to the Station, as determined by the Station in its sole discretion, will be eligible to participate in the "Score a Ford Contest" for the opportunity to win.

Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Winner Selection.** Station will play one (1) cue to call during each Contest Round (for a total of four (4) times per day) during the Contest Period Monday-Thursday and 2 times per day on Fridays. Caller five (5) as announced by the Station will be asked to guess the final scores for both teams for the regular season University of Tennessee ("UT") football game to be played that coming Saturday. Between 4:00

to 6:00pm ET each Friday of the Contest Period (except for **September 29th through October 4th and November 3rd through November 8th**), Station will select one (1) Qualifier (a “Selected Participant”) to win the Weekly Prize (as defined below) and have the opportunity to win the Grand Prize (as defined below) in a random drawing from among that week’s Qualifiers. If the final scores for **both** teams for the UT football game that week are exactly the final scores guessed by the Selected Participant, the Selected Participant will win the Grand Prize. The Grand Prize(s) is provided by Ted Russell Ford. If the Grand Prize is awarded prior to the final weekend of UT’s regular season, Prize Sponsor will supply additional Grand Prizes to continue the Contest for the remainder of the Contest Period so that the Contest runs each week of the twelve (12) UT regular season games. A Grand Prize will only be awarded if the Selected Participant perfectly predicts the final score for UT as well as their opponent. **The Selected Participant’s guess must match each team’s final total exactly.** The identity of the Selected Participant and the score guesses for the particular game will be announced numerous times prior to the UT football game kickoff during Station’s “Game Day All Day” broadcasts. Such information will also be placed on Station’s Twitter and Facebook accounts. In the event that a UT game is cancelled for any reason, or if a final score is not otherwise achieved, the Contest will not be conducted that week and no Grand Prize will be eligible to be awarded for that week. The Qualifiers will be notified at the time of the call, Selected Participants will be notified according to the process described above, and a Selected Participant that wins the Grand Prize will be notified using the phone number and/or email address provided to Station. Any prize is awarded to Qualifiers and/or Selected Participants subject to verification of eligibility and compliance with the terms of the rules. Station’s decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period, or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Unclaimed prizes may not be awarded.
6. **Prizes.** There will be up to twelve (12) Weekly Prizes awarded during the Contest Period. Each Weekly Prize is an oil change from Prize Sponsor (up to Fifty Dollars (\$50)) and a Fifty Dollar (\$50.00) gift certificate from Buddy’s Bar-B-Q. **The approximate retail value (“ARV”) of each Weekly Prize is One Hundred Dollars (\$100).**

There may be zero (0) to twelve (12) Grand Prizes awarded in this Contest. The number of Grand Prizes awarded depends on the number of Selected Participants that correctly guess the score of both teams of the weekly UT football game. Each Grand Prize winner will receive up to Seventy-Five Thousand Dollars (\$75,000) credit to use for the purchase of any new Ford or Lincoln vehicle on the lot or internet inventory of Prize Sponsor’s two (2) Knoxville locations. The ARV of each Grand Prize is **Seventy-Five Thousand Dollars (\$75,000).**

TOTAL ARV OF ALL CONTEST PRIZES IS UP TO Nine Hundred and One Thousand and Two Hundred Dollars (\$901,200).

Winner may choose to purchase a vehicle that exceeds the value of the Grand Prize, in which case, winner will be responsible for the difference of the actual cost of the vehicle they wish to purchase and the Grand Prize value. Winner will be informed of the actual ARV of the vehicle they wish to purchase at the time the Grand Prize is redeemed. Any difference between the Grand Prize value and the actual retail value of the vehicle the winner wishes to purchase will not be awarded. Winner acknowledges that winner will be provided a 1099 on the actual retail value of the Grand Prize that winner uses. Winner is responsible for all taxes associated with the prize receipt and/or use. Odds of winning a prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

There is no substitution, transfer, or cash equivalent for prizes, except that the Station may, in its sole discretion and to the extent permitted by law, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Any tickets and/or gift certificates/cards awarded as part of a prize will be subject to the terms and conditions set forth by the issuer and are valid only on the date(s) printed on the tickets or gift certificates/cards. Other restrictions may apply.

7. **Entry Conditions and Release.** By entering, each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Station, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Sponsor, Cumulus Media New Holdings Inc., and each of their affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a entrant's entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Contest and/or entrant's acceptance, use, non-use or misuse of the prize.
8. **Publicity.** Participation in the Contest constitutes entrant's consent to use by the Station and its agents of entrant's name, likeness, photograph, voice, opinions, entry, and/or biographical information (including hometown and state) for promotional purposes in any media, worldwide, without further payment or consideration, unless otherwise prohibited by law.
9. **Taxes.** All State, Local, Federal and/or other taxes, duties, tariffs, title fees, licensing fees, or other fees for prizes awarded become the sole responsibility of the winner. All those who win a prize or prizes valued \$600 or more in any given year will be issued an IRS Form 1099 to report their winnings.

10. **General Conditions.** Station reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Station in its sole discretion. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
11. **Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, Sponsor, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
12. **Disputes.** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
13. **Entrant's Personal Information.** Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained therein, shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.

14. **Contest Results.** A winners list may be obtained within thirty (30) days after the Contest Period expires by sending a self-addressed stamped envelope to the Station identified below.
